This means that the FBU campaigns on a wide range of issues including those directly and indirectly affecting officer members/middle managers. During 2006 the FBU successfully ran the campaign which convinced the government to make major concessions in relation to their proposed pension arrangements.

Protecting pensions

Most significantly, as a result of this campaign, plans to increase retirement age for existing employees were dropped.

Currently, the FBU is again leading the campaign to defend the ill-health provisions within the Firefighters Pension Scheme.

Which other representative body within the service has the resources or the expertise to make sure that the appropriate legal and political challenges are made? Which other representative body has the will to ensure its members, past, present and future obtain the best possible outcome to secure your pension?

The FBU is a trade union, but it is also a professional body which has always played a central role in protecting and developing the professional standards within our service.

Responding to IRMPs

FOA PLEASED WITH BACKDOOR ENTRANCE?



Members will now be aware that following the National Joint Council (NJC) meeting, held on Friday 28 September 2007, a new constitution was agreed for both the NJC and the newly formed Middle Managers Negotiating Body (MMNB).

This was despite a sustained four year attack upon the Fire Brigades Union (FBU) orchestrated by a Government who was prepared to promise anything to anyone who was willing to side with them against the FBU in the 2002-3 pay dispute.

This was a Government driven by the desire to drive a wedge between Officers and other firefighters because they were infuriated by the unity shown as officers took action alongside their colleagues in a claim for a justified increase in pay.

Smoke screen

They used the smoke screen of improving democracy to allow the Fire Officers Association to achieve national recognition for pay and conditions bargaining through the back door.

This back door was increased in size until it became large enough for those officers, or their representatives who aren't even in the fire service and who worked, apparently tirelessly, throughout the periods you were following a democratically agreed and legally approved strike, to leave. In fact to leave very quickly.

FBU Officer members need to be clear that none of this was about improving democracy but more about undermining it! And the FOA know it!

FIRE MINISTER PROMOTES WORKING WITH THE FBU, NOT AGAINST IT

At the Fire Conference in May the Fire Minister was keen to point out the benefits of working closely with the Fire Brigades Union. The Minister stated "it is important to maintain an excellent emergency response but also to work hard towards prevention and reducing the danger for people most at risk in our society. In both, the key to success is partnership." This was a clear message from the Minister to fire authorities and chief fire officers of the critical importance of the FBU.

She continued: "Two weeks ago I spoke to the FBU Annual Conference. It was time to reforge the links.

"There is no point denying that employment relations in the Fire and Rescue Service have been a bumpy path over recent years. However, the FBU is a crucial partner...."
